NOTICE

Subject: Inviting Applications for Fee Waiver under Antyodaya Anna Yojana (AAY) Fee Waiver Scheme – 2026.

In pursuance of Government Order No. 209-JK(HE) of 2026 dated 08.07.2026 and the Directorate of Colleges, Higher Education Department, J&K Guidelines dated 28.07.2026, applications are invited from eligible undergraduate students for grant of College Fee Waiver under the Antyodaya Anna Yojana (AAY) Fee Waiver Scheme.

1. **Eligibility:** Students fulfilling all of the following conditions are eligible to apply-

I. The applicant must be a bona-fide undergraduate student studying in Semester 1st to Semester 8th of the College.

II. The applicant must belong to an Antyodaya Anna Yojana (AAY) household, duly covered under the records of the Civil Supplies & Consumer Affairs Department (CAPD).

III. The applicant must not be receiving any other scholarship or financial assistance from any Central/State Government Scheme, including the Post-Matric Scholarship Scheme (PMSS) or any other source.

IV. The applicant's name should appear on the AAY ration card and the relationship with the head of the AAY household should duly be established.

2. Documents Required-

Eligible students are required to submit the following documents to the College Office:

- a) Duly filled Claim-cum-Declaration Form (Annexure-A) with self-declaration that the applicant is not availing any other scholarship/financial assistance.
- b) Self-attested copy of the valid AAY Ration Card, clearly mentioning the date and year, from where the household was put under AAY household scheme.
- c) Original AAY Ration Card for verification at the time of submission.
- d) Copy of College Identity Card/Admission Receipt (or any proof of admission/bona fide student status).
- e) Supporting document establishing identity linkage/relationship with the head of the AAY household (e.g., Matriculation marks card bearing the Names of Father and Mother clearly, in case one of them is the head of the AAY household).
- f) Any other document, required by the College Fee Waiver Verification Committee (May be demanded any time at a later stage).

3. Important Instructions

- * Applications must be submitted till **10th of August 2026** in the Department of Physics.
- * Mere submission of a copy of the AAY ration card and the other documents mentioned above does not guarantee the fee waiver. The AAY status will be verified through the prescribed procedure.
- * **Students found receiving any other scholarship/financial assistance shall not be eligible. If an eligible student is subsequently sanctioned a scholarship/assistance from any source, the student shall report the fact to the college forthwith, and his/her waiver shall be immediately withdrawn and the recovery of the same be initiated immediately.**

* If some student avails a waiver on the basis of an incorrect declaration or by concealing any fact at an earlier or a later stage, the amount shall be immediately recovered from him/her.

* Incomplete applications or applications submitted after the prescribed period are liable to be rejected.

Students are advised to submit their applications well before the last date to avoid any inconvenience.
