**Subject: Nominations for Tribal Awards**

Tribal Research Institute, J&K invites nominations for the First edition of Tribal Awards to be conferred by the Government of Jammu & Kashmir under various categories as mentioned below:

**A. Award for the Best Tribal Achiever**

Two awards covering each of the following fields (preferably one for a male Scheduled Tribe achiever and the other for a female Scheduled Tribe achiever):

- (i) **Sports** (Outstanding performance at UT/National/International level).
- (ii) **Education** (Outstanding performance in engineering, medical or any discipline at Graduate and Post Graduate level course).
- (iii) **Culture** (Outstanding and long time contribution in the performing arts such as dance/drama/visual arts, etc.)
- (iv) **Literature** (Outstanding and long time contribution in the field of literature).
- (v) **Science, Technology, Entrepreneurship and Biodiversity conservation** (Outstanding contribution).

Each award will carry a cash prize of Rs. 50,000, a citation and a trophy.

In total 10 Awards (5 for Male and 5 for Female) shall be conferred in the aforementioned category.

**B. Award for Exemplary Community Service rendered to the Scheduled Tribes:**

Two awards for exemplary work done among the tribal people in any field that has resulted in their rapid or remarkable development to:

- (i) Individuals
- (ii) Panchayat Raj Institutions
- (iii) Non-Government Organizations/Voluntary Organizations
- (iv) Community Based Groups/Organizations

Each award in this category will carry a cash prize of Rs. 50,000 a citation and a trophy.

In total 02 Awards shall be conferred in the aforementioned category.

**C. Award for the best performing Gram Panchayat/BDC/DDC**

Two awards shall be conferred to the best performing Gram Panchayat/BDC/DDC who has contributed significantly towards improving socio-economic condition of the Scheduled Tribes. Each award will carry Rs. 1.00 lakh cash prize, a citation and a trophy. The concerned Panchayat would be required to use the award money for creation of community assets. The award money can be dovetailed with the money available under any other scheme or their own funds.

In total 02 Awards shall be conferred in the aforementioned category.

**Procedure for Nomination, Screening and Selection:**

To be considered for the awards under Category A and B, a person or body would have to be recommended by a person of standing (public official, well-known personality, etc) who will vouch for the genuineness of the information submitted, as per format at **Annexures attached. Self-nomination will not be accepted.** For Category C (Best performing GP/BDC/DDC) concerned Deputy Commissioner shall forward the genuine cases to the UTLSC after getting the same approved in the DLSC. Nominations are to be made before the concerned Deputy Commissioner by or before **19-01-2022**. Nominations received after the due date will not be considered.

**District Level:** Nominations for awards under each category shall be made to the Deputy Commissioner of the District where the individual/ Organization normally resides/ is registered. The District Level Screening Committee (DLSC) headed by the Deputy Commissioner with a representative each from the District level Sports authority/Art and Culture/University/reputed NGO working in the field of tribal welfare as members of the DLSC shall verify the genuineness of the nominations; shortlist and recommend the shortlisted individuals/ Organizations, as the case may be, to the UT Level Screening Committee (UTLSC) by or before 23-01-2022. Recommendations received after the due date will not be considered.

**UT Level:** The recommendations made by the DLSCs would be screened and shortlisted by the UTLSC under the Chairpersonship of the Secretary of the Tribal Affairs Department. In case recommendations are not received from all or any of the districts, the UTLSC would proceed to make its recommendations taking into account only such recommendations received.



**Conditions rendering nominations in-eligible:**

- a) Nominations not received as prescribed above will not be considered.
- b) Nominations not received in prescribed proforma/incomplete in any respect and /or received after the last date will not be considered.
- c) Nominations found to be suppressing information or giving false and misleading information would be disqualified for the grant of an award.

All the nominations received at the District level are to be sent to the Director Tribal Research Institute J&K only at the below mentioned mail: **director-tri@jk.gov.in**

Nominations received through any other medium shall not be entertained.

The awards shall be announced on the eve of Republic Day (26<sup>th</sup> January) 2022 and the same shall be conferred to the awardees at a ceremony to be organised subsequently for which advance intimation shall be sent to the concerned.


